COVID-19 BUSINESS APPLICATION FORM FOR DISASTER RELIEF (2020)

The category of property qualifying to apply must be situated within an area affected by a disaster within the meaning of the Disaster Management Act 57 of 2002.

CONDITIONS

- i. The owner of the property must apply for the disaster relief rebate.
- ii. The application for disaster relief must be accompanied by such proof as the City of Johannesburg may reasonably require in substantiating the application.
- iii. The rebate shall be subject to such duration and limitations as the Council may determine in relation to a specific disaster or event.
- The rebate shall be any amount to a maximum of 100% of the current monthly rates. iv.
- All applicants must make sure that their property accounts are up to the date prior the declaration of the disaster alternatively payment arrangement must V. be made and submitted with the application for the rebate.
- vi. Application done on behalf of the property owners by an appointed agent must be accompanied by power of Attorney letter with the certified ID.
- vii. Companies that were operational throughout the lockdown will not be considered.

Documents required

Ι. All applicants are required to provide a documentary proof on how they are impacted by the declaration of the disaster under the Disaster Management act. ii. All applicants are required to provide financials prior the disaster and financial and during the disaster. NB: All the sections of the application must be completed and required support documents must be attached when submitting the application.
