Consent for Borehole

Application in Terms of the City Of Johannesburg Land Use Scheme, 2018.

- 1. An owner of land may submit an application in terms of the applicable Town Planning Scheme for consent for the sinking of a Borehole.
- 2. An application for consent as envisaged in subsection (1) above shall include the following:
 - a) Prescribed application fee. (Refer to fees schedule).
 - b) Covering letter addressed to: The Executive Director

- c) Application Information Form A.
- d) **Original** Power of Attorney (if applicable Form B)
- e) Company Resolution (if applicable Form C)
- f) A copy of the registered tittle deed for each erf that is included in the application. (3 copies)
- g) A copy of the company closed corporation, should the or trust property by registered in favour of one of the above.
- h) If the land is subject to a mortgage bond, full details of such bond holder as well as the bond holder's consent relevant to the application.
- i) Motivating memorandum in support of the application. (6 copies)
- j) Zoning and density zoning plan. (6 copies)
- k) Land Use Plan. (6 copies)
- I) Information on the existing development and use on the land.
- m) Proposed site plan, showing, *inter alia*, the following information:
 - (1) Site Information
 - a. Property description
 - b. Site area
 - c. Zonina

- d. North point
- e. Scale (1:100, 1:200 or rule) a site plan "not to scale" or "reduced scale" are not acceptable.
- f. Locality plan insert of the area on the site plan
- g. Clearly indicating the location of the Borehole as well as all alternative drilling sites.

(2) Engineering Services & Servitudes

- a. Indicate positioning of Engineering Services (Water, Sewer, Storm water and Electricity)
- b. Connection points of all Engineering Services
- c. Distinguish between internal services & Council services
- d. All Servitudes (including Right of Way) and Building lines

(3) Landscaping

- a. Existing vegetation: Trees & shrubs, Plant beds, Grassed areas, and any other relevant landscaped areas
- b. On-site storm water attenuation measures

(4) Off Site Information

- a. Streets and street names
- b. Width of street reserve/s
- c. Zoning and actual land use of adjoining properties
- d. Locality of buildings within 15m from common boundary
- e. Access points of adjoining development/s
- f. Servitudes
- g. Open space links to adjoining properties, inclusive of flood lines, ridges, rocky outcrops, etc.

- a. Erf boundary dimensions
- b. Building footprints (Dimensions)
- c. Parking layout, including dimensions and maneuvering space
- d. Internal roads (width)
- e. Entrance/s (width)
- f. Bell mouth entrance (heavy duty kerbing Radius of 6,5m) where applicable
- g. Elevations (At least two) reflecting natural ground level and cut and fill
- h. Height of buildings
