

Application for Residential Property Rates to be levied on property zoned General, Special and Undetermined

From 01 July 2023 to 30 June 2024

I wish to apply for the residential rates tariff for my property.

The City of Johannesburg has been charging rates according to the zoning of the property in terms of the Town Planning Scheme. The above-mentioned property has not been zoned as residential and the City of Johannesburg has therefore applied the business tariff as the rate is governed by the zoning of the property.

Although the property is not zoned as residential, it is however used for residential purposes. It is against this usage of the property, that I am making an application to the City of Johannesburg to apply the residential tariff instead of the business tariff as from the date of application.

I understand and agree that the Council, through its Municipal Valuer or any other Department, may inspect the property. I undertake to advise the Council in writing should the usage of the property be changed from solely residential to any other form of commercial use.

I further understand that this residential tariff, if granted, is personal to myself as the present owner and will not be passed on to a succeeding owner of the property.

NB.: Applications for a sectional title scheme may be done by the body corporate or managing agent or individual on behalf of all units. Separate application forms are not required for each unit. Only one application form must be submitted and a list of all the units/sections with corresponding rates account numbers, names and contacts must be attached. **However, A REFERENCE NUMBER MUST BE PROVIDED FOR EACH UNIT when submitted and captured at the CoJ Customer Service Centre.**

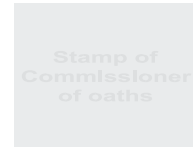
